wahidjamainurdupdf14 London (CNN) -- The mother of a British rape victim who died in August was denied an injunction to delay the trial of the man accused of murdering her, according to her lawyer. Vicky Pryce was struck and killed in London as she was walking to her home. Police have linked her death to that of a man, Liam Allan, who raped her on August 5, 2009. He has been charged with her murder. Allan's friend, Thomas Hamilton, is charged with assisting an offender. On Sunday, Ms. Pryce's parents in Wales received a message from their eldest child, Rebecca Cox, through Facebook asking them for money, the Sunday Times reported. A message from Ms. Cox was then posted on Facebook in which she said "having called the police and the BBC for donations, I am struggling as I have just

found out that my mother has been found murdered." The BBC reported that Ms. Pryce's parents received another message from their daughter later in the evening. Ms. Pryce's brother-in-law then posted a message on Facebook on Sunday saying that the BBC had given an interview on how the family "felt about Vicky's death." The family has since received numerous messages asking for help to cover funeral costs, according to the Sunday Times report. The BBC said in a statement that it "expressed its profound sympathy to the family. We have offered them the support we are able to provide." "We are trying to be as helpful as we can to the family," a family friend told the BBC. Roland Rudd, the lawyer representing the family, said in a statement that the couple have asked that the court "suspend the proceedings" and allow "the family to grieve in peace." Prosecutors say that Hamilton knew Allan was going to rape and murder Ms. Pryce and tried to stop him. The trial is scheduled to resume Monday at

the Central Criminal Court in
